The Relief Chest Scheme can now accept Direct Debit instructions online. Setting up a Direct Debit to make a regular donation to a Relief Chest online is convenient and safe.

Benefits of Paperless Direct Debit:

- Clear and simple sign-up process.
- The details are verified at the sign up stage as are the bank details.
- Reduced time spent querying details.
- Paperless system.
- Not reliant on a postal service.
- Safe and secure process via Grand Charity's website.
- Gift Aid tax relief (where applicable) is reclaimed.
- The same safeguards and guarantees as paper Direct Debits apply.
